ORDER.

The Government of Arunachal Pradesh hereby accorded approval of formal recognition to The Navjyoti English School, Bhalukpong, West Kameng district Arunachal Pradesh run and managed by the Lelang futhu (HRUSSO) Aka welfare Association Society under Societies Act of 1860 for running classes up to Middle level with effect from 13/06/2016.

The recognition is granted on the following terms and conditions:-

1. The guidelines in respect of recognition of school conveyed through order No.EDA.20/90-91 (Vol-II), dated 9th Oct / 2012 shall have to be observed in letter and spirit. Further, the recognition of the school does not carry any financial commitment from the Govt. side.

In addition, the following additional guidelines shall be strictly complied with:-

2. Arunachal Pradesh traditional culture must be preserved.
3. Syllabus prescribed by the Directorate of School Education AP/CBSE, New Delhi, for the school will have to be followed.
4. No religious activity should be under taken either directly or indirectly in the school and hostel campus.
5. There should be emphasis on the quality education.
6. Norms of recognition applicable in respect of other educational institution shall also be applicable to the above institution.
7. Direct or indirect violation noticed in respect of the above mentioned conditions may lead to deterrent action including closure of the school.
8. Govt. will not be bound to provide any land allotment in case of any such School.
9. Government reserves the right to cancel, revoke or rescind the reorganization at any stage in the event of any violation of the terms and conditions prescribed here in the event of violation of other rules in force.
10. Safety provisions in case of fire accidents will have to be provided in all schools/ Hostel Buildings.
11. The school in charge will keep special watch on child and Girl children abuse/ molestation. A Nodal officer will be appointed in this regards.

12. No church, temple, mosque or any other religious activity shall be carried out within the school campus.
13. No preaching in the disguise of seminar, discourse/ talk by any religious Body or patrons or preachers of any religious institution will be acceptable.
14. The Principal of the school and the Secretary of the governing body must report to the prescribed Govt. authority from time to time to indicate whether the above mentioned Govt. instructions are being observed.
15. The Deputy Commissioner of the district or any representative authorized by him or DSE/DEE will be free to obtain necessary feedback from any such school by way of inspection / calling for report etc.
16. If in view of the Deputy Commissioner there is any communal turn due to any reason related to such religious activity in the school or if any disaffection is caused amongst the students as mentioned in clause 13 above, then the Deputy Commissioner will have the right to initiate appropriate action against the authorities of the school and inform the Govt. about the action taken accordingly. This has the approval of Hon,ble Minister Education vide U.O No. 161 dated 13/06/2016.




